Annex 2

Terms and conditions of the minimum monthly payment

1. A customer who undertakes the minimum monthly payment obligation will obtain a mobile phone, modem, laptop, PDA/MDA or another terminal at a special price or another benefit according to T-Mobile's current offer. It is possible to undertake the minimum monthly payment obligation when entering into a new Subscriber Contract or when extending the existing Subscriber Contract. The customer will specify the amount of the minimum monthly payment in the respective form. This amount cannot be altered during the period for which the obligation lasts.
2. A customer who has undertaken the obligation of a minimum monthly payment for an agreed time is obliged to use, during the period for which this obligation lasts, at least such a volume of telecommunications services each billing period so that the amount charged for these services is equal to the minimum monthly payment. The items listed in Annex 1 below are not included in the minimum monthly payment. T-Mobile may amend this Annex 1 at any time.
3. The minimum monthly payment obligation always relates to the Subscriber Contract. Thus, if more than one telephone number subject to the minimum monthly payment obligation is billed in one summary Statement of Services, the customer must meet the minimum monthly payment obligation for each of such phone numbers separately.
4. If the customer breaches the obligation to reach the agreed amount of payment for a specific phone number, T-Mobile is entitled to a contractual penalty in an amount corresponding to the difference between the amount billed and the minimum monthly payment. If the customer breaches the obligation to reach the minimum monthly payment for the entire agreed term, T-Mobile is entitled to a contractual penalty in an amount corresponding to the difference between the sum of the monthly fees remaining from the moment the obligation was breached until the expiry of the agreed term and the sum of the minimum monthly payments remaining from the time the obligation was breached until the expiry of the agreed term. This shall not affect T-Mobile's right to other contractual penalties in accordance with the General Terms and Conditions or other payments.
5. The agreed term of adherence to the minimum monthly payment obligation shall be extended for the period for which service on the SIM card has been suspended. If service on the SIM card is suspended for a part of the billing period, the customer is obliged to adhere to the proportionate part of the minimum monthly payment obligation. If the SIM card is blocked due to a breach of the customer's obligation (e.g., due to non-payment), this shall not affect the customer's obligation to adhere to the minimum monthly payment in relation to the respective SIM card.
6. In the case of transfer of the Subscriber Contract, the minimum monthly payment obligation is automatically transferred to the new subscriber. The original subscriber is obliged to inform the new subscriber of the existence of this obligation, its amount and the remaining period of duration. The new subscriber cannot

claim in relation to T-Mobile that he/she did not know about the existence of the minimum monthly payment obligation.

7. These terms and conditions shall become effective on 2 December 2009.
8. T-Mobile may amend these terms and conditions; the currently valid version shall be always available at www.t-mobile.cz.

T-Mobile Czech Republic a.s., having its registered office at Tomičkova 2144/1, 149 00 Prague 4, Company ID 64949681, registered in the Commercial Register administered by the Municipal Court in Prague, Section B, Insert 3787 ("T-Mobile"), offers customers (with the exception of customers with the Frame Contract) laptops at a special price.
2. Customers can purchase the laptop at a special price when entering into a Subscriber Contract with a data tariff plan (4G Basic, Standard or Premium) or a voice tariff plan. Customers can also purchase the laptop when extending their Subscriber Contract with a data or voice tariff plan. When entering into or extending a Subscriber Contract with a data tariff plan, customers can also purchase the 4G Combi card or 4G modem for internet access. If a customer is purchasing the laptop at a special price when entering into or extending the Subscriber Contract, this fact will be specified in the order of services or amendment to the Subscriber Contract. If the customer purchases the laptop at a special price when entering into or extending the Subscriber Contract with a voice or data tariff plan, 4G Combi card or 4G modem, the Subscriber Contract is governed by the following special terms and conditions:
 - a) The promo event offering unlimited internet access for up to six months free of charge where the customer does not have to pay the monthly fee for the data tariff plan for six months (when entering into a 24-month Subscriber Contract) or three months (when entering into a 12-month Subscriber Contract) does not apply to the Subscriber Contract. Thus, the customers who have purchased the laptop at a special price are obliged to pay the monthly fee from the beginning of the contractual relationship.
 - b) The Subscriber Contract is always entered into or extended for a fixed period of 24 months. Customers who have purchased the laptop at a special price are obliged to adhere to the minimum monthly payment obligation the amount of which is agreed in the order of services or amendment to the Subscriber Contract for a period of 24 months. Otherwise they shall pay the contractual penalty specified in the terms and conditions of the minimum monthly payment.
 - c) Since customers do not provide a deposit when extending their Subscriber Contract, which could cover the risk of fraudulent conduct, the offer of purchasing the laptop at a special price when extending the Subscriber Contract only applies to customers who have had a concluded Subscriber Contract with T-Mobile for more than twelve months. Another prerequisite for the extension of the Subscriber Contract is an active Internet 4G Basic, Standard or Premium tariff plan at the time of contract extension. All conditions specified in the previous paragraph also apply to the extension of the Subscriber Contract accordingly.
 - d) Customers who wish to obtain the laptop at a special price have the opportunity to enter into a Subscriber Contract, extend their Subscriber Contract and have the laptop and related equipment (e.g., the 4G Combi card or 4G modem) delivered outside T-Mobile shops. Subscriber Contract extension, the laptop and related equipment can be ordered on the T-Mobile website or by calling the T-Mobile Customer Centre. On the T-Mobile website or during the phone call, the customer will select the place and time of delivery. The parcel will contain the Order of Services – Proposal to Enter into a Subscriber Contract form or the Amendment to the Subscriber Contract form, the laptop, additional equipment, information materials and, if applicable, other products or documents based on the customer's choice. Upon delivery, the customer will sign the respective form and upon the fulfilment of the conditions necessary for the conclusion of the Subscriber Contract, the customer will accept the proposal to enter into a T-Mobile Subscriber Contract by activating the SIM card. The Subscriber Contract is thereby concluded. Due to the fact that in such cases, the customer has explicitly agreed (either via the website or during the phone call) on a visit for the purpose of an order pursuant to Section 57 (1) of the Civil Code, he/she does not have the right to withdraw from the Subscriber Contract without stating the reason and without sanctions pursuant to the legal provisions on consumer contracts.
 - e) T-Mobile has the right to agree with a customer who has purchased the laptop at a special price on a premature termination of the Subscriber Contract. If the Subscriber Contract is terminated prematurely by agreement, the customer is obliged to pay financial compensation for premature contract termination to T-Mobile in the amount of the difference between the special and the full price of the laptop from which the minimum monthly payments throughout the term of the Subscriber Contract will be deducted. The statutory amount of VAT shall be always added to the amount calculated in this manner. However, the financial compensation shall never be lower than CZK 100 incl. VAT. The full laptop price shall be determined according to the last valid Price List. The customer is obliged to pay the financial compensation to T-Mobile within the time limit specified by T-Mobile. The customer acknowledges that the obligation to pay financial compensation constitutes an obligation arising from the Subscriber Contract, and the authority to decide about such obligation first is the Czech Telecommunications Office.
3. These terms and conditions shall come into force on 1 October 2008. T-Mobile may alter these terms and conditions and the new version shall always become effective on the date of its publication at www.t-mobile.cz, unless another beginning of effect is stipulated.

The Internet Komplet Terms and Conditions or any part thereof may also be communicated via other means, e.g., print advertising, billboards, etc. In the event of discrepancies between the text of the Internet Komplet Terms and Conditions published on the internet and the text of the Internet Komplet Terms and Conditions published in another manner, the text published on the website specified above prevails.
